# PAN-EUROPEAN BORROWERS DEMOCRATICALLY ACCOUNTABLE

From financing the European Green Deal to assistance for Ukraine, institutions with the authority to raise funds on financial markets to provide grants, loans and guarantees to public and private actors, are playing an increasingly prominent role in the European Union's response to a variety of economic, political and societal challenges. With this increased role comes a greater need for integrating a broad range of public stakeholders, including parliaments and civil society, into the decision making process. Democratic accountability is crucial to make sure that the actors and projects receiving public money prioritise environmental and social policy objectives. The European Parliament, national parliaments and civil society are in urgent need of more robust mechanisms for holding these institutions to account.

The aim of this workshop is to exchange knowledge and good practice about how the democratic accountability of the European Investment Bank, the European Commission and the European Bank for Reconstruction and Development can be strengthened to ensure that these pan-European borrowers fulfil their public missions and objectives, and do no harm.

# The event is co-organized by Counter Balance and Banking on Europe.

Counter Balance was launched in 2007 as a campaign aimed at reforming the European Investment Bank (EIB). While the EIB remains its main target, it has since then expanded the scope of its work to other public finance institutions.

Banking on Europe is a three-year research project on the evolution and accountability of pan-European borrowers funded by the UK Economic and Social Research Council and the Luxembourg National Research Fund.
